Australia: Transsexual Marriage is valid (without lower surgery) Transsexual marriage is valid By CINDY WOCKNER Legal Affairs Editor 15 Oct 01

A couple have won a legal battle to have their marriage declared valid after the husband, a female to male transsexual, was declared a man by the Family

Court. In a landmark judgment, the Family Court confirmed the marriage was valid and that the definition of "man" should be based on contemporary thinking and not on outdated ideologies.

Justice Richard Chisholm's decision, considered to be significant in terms of the law regarding transsexuals, hinged on when a man is a man.

The Federal Attorney-General opposed the case, arguing the husband was not a man under marriage law. He submitted the meaning of the word "man" in the Marriage Act should be the meaning given when the Act was passed in 1961 - whether a person was a male at birth. The latest decision is at odds with a 1971 English decision known as Corbett, which had been a guide on the subject. Justice Chisholm said "man" should be given its ordinary contemporary meaning. The husband, known as Kevin, was born a girl, with female genitalia and chromosomes. But for as long as he could remember he had perceived himself to be male and had worn boy's clothes and played with boy's toys. From 1994 Kevin presented as a male, started hormone treatment in 1995 and in 1998 had sexual reassignment surgery, but has not had surgery to construct male genitalia. Kevin met Jennifer in 1996 and a year later they were living as a de facto couple, having been told they could not marry legally.

In 1998 Kevin was issued with a new birth certificate showing his sex as male. Then in 1999 the pair were issued with a Certificate of Marriage by a marriage celebrant. The Attorney General disputed the validity of the marriage certificate.

The couple have a child, conceived under the IVF program and have been successful in a second IVF application. Justice Chisholm said the evidence of 39 witnesses who testified for Kevin was striking. "They see him and think of him as a man, doing what men do. "They do not see him as a woman pretending to be a man. They do not pretend that he is a man, while believing he is not . . . They are describing what they see in Kevin. And what they see is a man," Justice Chisholm said.

In his conclusion the Judge said there was no persuasive reason to assume, for the purposes of marriage, that "if a person is a male or female at birth, the person must be a male or female at the date of the marriage".

SAN FRANCISCO - A federal appeals court has overturned a lower court ruling saying that a male restaurant worker who was taunted for walking

"like a woman" can sue the company under federal laws prohibiting sex discrimination.

Antonio Sanchez was a waiter in a Seattle restaurant of Azteca Restaurant Enterprises where he claims he was subjected to daily verbal abuse by coworkers and a supervisor. Sanchez said he told several managers and the human resources director about his problem, but did not get a significant response. He was fired a few months later for walking off the job in the middle of his shift. Sanchez filed suit in district court, which ruled against him saying he had not been subjected to a hostile environment based on his sex. The 9th Circuit Court of Appeals overturned that ruling, saying that the "unrelenting barrage of verbal abuse" was severe and pervasive. The appeals' court decision was a departure from other court rulings that have made it difficult for gays to obtain protections under Title VII of the Civil Rights Act because the law does not cover sexual orientation.

However, in Sanchez' case there was never a suggestion that the plaintiff was perceived to be gay. Rather, he was subject to harassment based on the fact that he did not conform to sexual stereotypes. The court based its decision on a 1989 U.S. Supreme Court ruling that barred discrimination on the basis of "sexual stereotypes.

Associated Press, October 16, 2001 Ruling allows transsexuals to sue under disability, discrimination laws By Jay Lindsay, Associated Press BOSTON - For the first time, the state's anti-discrimination and disability laws have been interpreted by the Massachusetts Commission Against Discrimination to grant protections to transsexuals. The rights of transsexuals under those statutes have never been explicitly addressed by the Legislature, and some say the decisions required contortions of state laws. But advocates for transsexuals hailed them as an important step forward.

"They're fantastic decisions," said Jennifer Levi, an attorney with the Gay & Lesbian Advocates and Defenders. "There's no principled reason to exclude transsexual people from the law's protections." Transsexual people believe they should be the opposite sex, and sometimes undergo sex-change surgery. They differ from transvestites, who wear the clothes of the opposite sex, but don't desire a sex change. The MCAD decisions, both dated Oct. 10, did not determine the guilt or innocence of the defendants, but cleared the way for an MCAD investigation to determine probable cause in each case. The MCAD is authorized by the state to interpret anti-discrimination laws. In one case, first filed in 1995, a transsexual woman named Rachel Jette claimed that her boss at a Honey Farms convenience store in Worcester County harassed her by forcing her to use her birth name, Raymond, and wear men's clothes to work. She later amended her complaint, charging she was discriminated against because of a "handicap or perceived handicap." The MCAD ruled that though transsexuality isn't defined as a disability or covered under disability discrimination laws, it's not specifically excluded either, even though the laws were modeled after federal statutes that excluded transsexuality. "Since the legislature was aware of the exemptions for coverage of transsexuals and did not include such ... it must have intended to include such coverage," the commission wrote. A lawyer for Jette did not return a call for comment. Honey Farms attorney Mark Bloom declined comment. David Yas, an attorney and publisher of Massachusetts Lawyers Weekly, said the definition of transsexuality as a disability might upset some who consider the condition natural. Levi said the only problem is the stigma associated with disability, saying because transsexuality often requires medical care, it's on par

with other disabilities such as poor eyesight.

The other case involved a male-to-female transsexual named Charlegne Millett, who alleged in December 1998 that her supervisor at Tutco, Inc. in Worcester disciplined her because of her transsexuality and threatened to fire her after she complained. The MCAD said sex discrimination laws could apply in Millett's case because she says she was harassed "because of the kind of man she is – one who wanted to be a woman."

In general, transsexuals are protected by the law because they're often discriminated against for failing to conform with society's expectations for each sex, the MCAD said.

Tutco attorney James W. Bucking said the MCAD decision is a "leap," that creates laws about transsexuals where none exist. Current laws protect men and women who are discriminated against solely because of their sex, not because of any desire to change their sex, he said. "They're basically saying sex is an elastic concept, not concrete," Bucking said. "But sex is not an elastic concept."

MCAD chairwoman Dorca Gomez said there's limited case law on the issue, but the commission based its decision on those laws.

"The statute specifically says interpretations must be made broadly," she said. Yas said the ruling may prompt the Legislature to consider transsexual rights. "I think attorneys would say, 'Yes, it is a liberal ruling," he said. "It's also a possible invitation to the Legislature to amend the ruling."

Two men sentenced to wear dresses Friday, October 26, 2001 Mike Lafferty Dispatch Staff Reporter The judge gave them two options -- 60 days in jailhouse orange or an hour long walk down Main Street in a frock.

Jason Householder and John Stockum, convicted recently in Coshocton County of criminal damaging for tossing beer bottles at a car, chose the dresses.

Denting the car, however, was not what drew the unusual sentence from Municipal Court Judge David Hostetler -- it was their rude behavior toward a woman in the car.

"It's not illegal to be obnoxious, it's just rude," Hostetler said yesterday. "Throwing the beer bottles put them across the line and into my clutches." Householder, 23, and Stockum, 21, both Coshocton residents, will serve their sentences from 4 p.m. to 5 p.m. today. Hostetler's sentence has drawn support from locals. "I may close up long enough to go see," said Tina Dobson, who operates a downtown gift shop. "I'm going to be a little excited to see how it turns out, but not too excited," said Larry Miller, a probation officer who has the job of making sure the sentence is carried out.

Householder and Stockum were riding with another man in a car Oct.

13 in Coshocton when they stopped next to a man and a woman in another car, authorities said. One of the three men made a derogatory comment toward the woman, then the trio followed the couple through downtown, about 65 miles east of

Columbus. At one point, Stockum and Householder threw several beer bottles, denting the car.

The third man in the car, who was not identified and did not throw bottles, was not charged.

Hostetler has a reputation for unusual sentences. He said the overcrowded Coshocton County jail forces him to be creative. "I've got a jail with 52 people that's supposed to hold 36," he said. "You run out of options." The judge frequently orders people convicted of a second or third speeding violation to write essays. When vandals were found guilty of throwing eggs, Hostetler ordered them to write "I will not throw eggs" 1,000 times. When vandals broke \$19,000 worth of automobile windows, Hostetler ordered them to auction their possessions to pay for the damage. "I got everything from paintball guns to baseball-card collections," he said.

When Householder and Stockum appeared before Hostetler Oct. 18, the judge ordered them to be more respectful of women and fined them each \$250.

"I ought to make you walk up and down Main Street dressed as a woman," Hostetler told the two men.

He ordered them to dress "demurely." "We're not doing the bikini top and thong," he said. "It's got to be a dress, and it has to be respectful. They are going to don a wig and a little makeup. "Both have sisters who are going to help."

Our Purpose

The Crystal Club is a non-profit social and support group for transvestites, cross dressers, transsexuals, and other transgendered individuals. Spouses and significant others are welcome and encouraged to participate. Both male-to-female and female-to-male individuals are welcome. Also, members from related organizations, helpful professionals and approved guests are welcome when cleared through a Crystal Club officer.

What to Expect at a Meeting

Except for being transgendered, participants in the club are just like other people. We dress pretty much like average people, and meet only to socialize and participate in club functions. We range in age from our 20's to our 60's, and come from a wide range of professions. Most of us are cross dressers, although several of us are transsexuals. Most of us are married and have kids, and often our spouses attend the meetings, too. Nothing of a sexual nature is permitted at any of the meetings.

You will not be criticized for how well you dress or pass. The club isn't a beauty contest. We range from hardly convincing to completely passing. Some of us dress up, some dress down. Come however you are comfortable. Our regular meetings will have a private changing room, so you may bring a change of clothing with you.

We do insist, however, that you dress either completely male or completely female. Gender-blending attire is normally not an option. We also insist that everyone behaves as ladies and gentlemen (which is more polite than simply "women and men"). Overtly sexual or obnoxious behavior is unwelcome; we don't need to exasperate the feelings of people who are already nervous!

You will not be required to reveal your legal name, or any other personal information. You can be as open or anonymous as you wish. We ALL have been newcomers and have had similar feelings. We can (and will) sympathize completely!
