The National Center for Lesbian Rights and local attorney Collin Vause represented Michael Kantaras in a divorce and custody case in which Michael's wife asked the court to declare him a legal stranger to the couples two children.

TAMPA, FL -- <u>In a groundbreaking decision</u>, Florida Circuit Court Judge

<u>Gerard O'Brien</u> ruled today that <u>Michael</u> <u>Kantaras</u>, <u>a transgender man</u>, is <u>legally male</u> and was <u>legally married</u> to his former wife Linda

Kantaras, stating that "the Court has carefully reviewed all the pleadings, record evidence, expert medical testimony, lay witness testimony and the Appropriate statutory authority for marriage in Florida and concludes the overwhelming weight of evidence favors declaring the marriage valid." Final Judgment at pp. 806-07. The court also awarded Michael primary custody of the two children he and Linda raised together during their marriage.

Judge O'Brien's opinion is one of a handful of decisions addressing marriages involving transsexual spouses, and one of the first in the United States to hold that such marriages are valid.

The only states with similarly favorable decisions are New Jersey and California; in contrast, Texas and Kansas courts have held that marriages involving transsexual individuals are void. *Internationally*, courts in a number of countries have affirmed the validity of such marriages, including a very recent decision by the *Family Court of Australia* upholding a marriage between Kevin J., a female-to-male transsexual, and Jennifer, his wife.

After completing sex-reassignment, Michael Kantaras met and married his wife, Linda in 1989. Linda was fully aware of Michael's transgender status prior to the marriage and permitted Michael to adopt her then three month old son. The couple later had a daughter through alternative insemination. The Kantaras children are now ages 14 and 11.

When the couple divorced in 1999, the focus soon shifted away from the best interests of the children and onto Michael's transgender status. Linda argued that Michael should be considered legally female, their marriage deemed void, and his parental rights stripped away. The *three week hearing*, which included extensive testimony from medical experts, was covered live by *Court TV* last January and February.

''I'm so relieved,'' said an exhausted Michael

<u>Kantaras.</u> "Now my kids and I can get on with our lives in peace."

"The court recognized that the two children in this case have a devoted, loving father and need to maintain a relationship with both their parents," said NCLR Staff Attorney Karen Doering, co-counsel in the case.

"This court recognized that Michael's transgender status has nothing to do with his ability to be a good parent. Michael is a loving, responsible father who also happens to be transgender."

According to NCLR Legal Director Shannon Minter, "To our knowledge, this is the first transgender marriage case in the U.S. in which extensive medical evidence was presented, including testimony from three of the foremost experts on transsexualism in the country. As the Court has recognized, the medical evidence overwhelmingly favors recognizing that the law should accommodate transgender people so they can be productive,

functioning members of society. This includes permitting transgender people to marry and raise children."

"This is not only a victory for the transgender community, it's a victory for the Kantaras children who deserve to have their loving father remain a part of their life," said Equality Florida Executive Director Nadine Smith. "We all benefit when gender stereotypes and bigotry are defeated."

Are Transmen required to Register for Selective Service?

I was asked a very interesting question, which was, "Do FtMs have to register with the Selective Service?" I never thought of it, but it is a great question. I called the Selective Service at (847) 688-6888 and found out that Female to Male transsexuals are exempt from registering with the Selective Service, but they need the Selective Service to give them a letter stating so. This question has come up before, and the Selective Service will type up this letter saying plainly that you are exempt from registering, but will not say why. This letter is important if an FtM applies for educational loans and a few other things where that question is asked, "Did you register for the draft?" They have to have that letter, or face the possibility of getting into serious trouble.

Since there are a lot of <u>FtM's who are</u>

<u>between the ages of 18 and 26, then this is important</u>

<u>information for them to have, whether there is a</u>

<u>draft or not.</u> This has to get out to all the young men in our community. <u>Spread the word</u>. The Selective Service is prepared for this, so call them if you have any questions. <u>Each young FtM must have this letter</u>

in their files.

Married Couple Swaps Sexes, Causes Riot

A Hungarian couple have given new meaning to the idea of wife-swapping with a pair of

controversial sex-change operations that changed their sex - and started a hospital *riot*. Both partners in the unnamed couple underwent successful sex reassignment surgery, with him becoming a her and her becoming a him at a clinic in the southern city of Szeged. But patients in the women's ward rioted after finding out about their new comrade, who had to be moved to the men's quarters, tabloid daily Blikk said. A doctor at the clinic told AFP he was horrified that details of the case had <u>leaked out. A former patient who also had a</u> sex-change was attacked by skinheads after his name was revealed in the press. The couple become the country's first pair to swap sexes.

Editorial Note:

I called (847) 688-6888 in an *attempt*

to verify or deny the information in reference to <u>selective service</u>. I was given a different number to call <u>((703) 605-4100)</u> because the people at the (847) number said they couldn't give legal advice.

The folks at the (703) number said that they <u>base registering on what sex you were legally at birth..</u>

So <u>FtM's are exempt</u> as the article states, however, <u>MtF's are not exempt</u>.

Further, I contacted one military contact (who didn't want there name used) who said that the Marine Corps would disqualify you for military service because they would wish to avoid any possible problems due to others opposing viewpoints.

However, it should be noted that each service may have a different policy.

Our Purpose

The Crystal Club is a non-profit social and support group for transvestites, cross dressers, transsexuals, and other transgendered individuals. Spouses and significant others are welcome and encouraged to participate. Both male-to-female and female-to-male individuals are welcome. Also, members from related organizations, helpful professionals and approved guests are welcome when cleared through a Crystal Club officer.

What to Expect at a Meeting

Except for being transgendered, participants in the club are just like other people. We dress pretty much like average people, and meet only to socialize and participate in club functions. We range in age from our 20's to our 60's, and come from a wide range of professions. Most of us are cross dressers, although several of us are transsexuals. Most of us are married and have kids, and often our spouses attend the meetings, too. Nothing of a sexual nature is permitted at any of the meetings.

You will not be criticized for how well you dress or pass. The club isn't a beauty contest. We range from hardly convincing to completely passing. Some of us dress up, some dress down. Come however you are comfortable. Our regular meetings will have a private changing room, so you may bring a change of clothing with you.

We do insist, however, that you dress either completely male or completely female. Gender-blending attire is normally not an option. We also insist that everyone behaves as ladies and gentlemen (which is more polite than simply "women and men"). Overtly sexual or obnoxious behavior is unwelcome; we don't need to exasperate the feelings of people who are already nervous!

You will not be required to reveal your legal name, or any other personal information. You can be as open or anonymous as you wish. We ALL have been newcomers and have had similar feelings. We can (and will) sympathize completely!
