Membership Dues

Crystal Club membership dues are \$15 per year for cross dressers. Couples (a cross dresser and a

GG) may also join at \$15 for the couple. Dues are due and payable July 1 of each year, and cover the period from July 1 to the following June 30.

As we do not yet have a bank account, we prefer that membership dues be paid in cash at a meeting, or to one of our officers (Susan, Mary Ann, Kelly, or Rochelle.) We are working on getting the account, however, and hope to have it by July 1. We will accept checks or money orders made out to Crystal Club (or left blank, if you're brave) mailed to the PO Box, if you cannot attend the meeting. We may have to hold onto the check for awhile if we have trouble cashing it, but we will honor your membership.

We strongly recommend that you pay your dues at the June meeting or by mail at the same time. The July newsletter, and attendance at the July meeting, will be open to paid members and firsttime attendees only.

First time attendees are welcome to attend, and should pay the meeting fee. After one meeting, the prospective member should know whether they want to join or not. We recommend that she join (by paying membership dues) at that same first meeting, if she chooses to join. This will give her voting rights, get her on the mailing list, and permit attendance at future meetings.

May Meeting

The May 27th meeting was small but good and productive. I felt it was more like a support meeting than other meetings I have been to. I thought the meeting was going to be short and uninteresting because of the small turnout due to the Memorial Day Weekend. I hope that I remember not to underestimate small meetings again.

C.T. and Nelli came from Zanesville (CD and GG) and shared some very interesting experiences and input. Coming to a CD support meeting was a first for C.T. and Nelli, we're glad they came

and hope they decide to come again.

Also coming out for the first time was Stephany, who we were happy to see and talk to, and hope to see again.

It was also mentioned at the meeting that membership fees are due and payable anytime for those of you who want to become members. Since we do incur a cost to operate, send out a newsletter, and so on, there is a limit as to how long we can send out monthly newsletters to nonmembers. So please consider sending in your membership fees. We will announce in the near future when we have an official bank account for the Crystal Club. Incidentally, if any of you ladies know of a financial institution that offers checking accounts with no monthly service charge, please let us know.

At the May 27th meeting we discussed whether the Crystal Club should take part in the Stonewall Union's Gay Awareness Parade. We decided to decline participation, primarily because our group is too new and not established enough, we don't have anybody who is out of the closet enough to stay in the booth and we are concerned about poor coverage or misrepresentation by the television media. However, we also decided that we should watch and study this event for the possibility of participating next year. We feel this could be a good opportunity to educate the public. We certainly encourage your input here. Remember the Transgender Community is your community, what would you like to see happen?

Most of the girls at the meeting went out to the Grotto afterwards. There was an F.I. show. the show was fairly good but the bar was a little smoky and loud for my taste. If any of you ladies know of other places where we are welcome that is on the quieter side please let us know.

Speaking of places to go, we are welcome at the Wall St. Bar. Also I talked to one of the owners of the Grapevine Restaurant. She said we are welcome there, however, daytime would not be good because the crowd is much different, mostly business people who are uninitiated to our CD culture.

For those of you who are thinking of coming to the June 24th meeting, we need for you to respond beforehand so that we can make adequate preparations for the meeting. Also, at a certain point, and we hope that it will be soon, we will have guest speakers on various things like makeup, theories on cross dressing, etc, but we need a few more people in attendance.

A project the Crystal Club has decided to work on is a shoppers guide for CDs, where as the place where the product sold or service rendered is done where CDs are welcome as such and consequently get better service.

For example, being able to try on clothes before you buy them, or getting assistance in size and style. Naturally the guidelines for different shops will vary and there will be some shops that will prefer that you don't come dressed. If anybody knows of any stores or services being done one this or similar basis, please share it with us. We are of course interested in places in Central Ohio.

At a certain point we want to put an ad in the Columbus Free Press and even prepare a news release. Here again your input is encouraged, what would you like the public to understand about us?

National Affiliation

The Crystal Club is currently a local, independent, support group for cross dressers and their SO's. There are some benefits from national affiliation, such as being mentioned in national directories, so that local ladies who write to the national group can be referred to us.

There are three major national (or larger) cross dressing organizations:

- 1. Tri-Ess (SSS, the Society for the Second Self,) 20-30 local chapters.
- 2. Renaissance, 7 local chapters.
- IFGE (International Foundation for Gender Education,) 51 affiliated organizations, including Tri-Ess, Renaissance, 5 Tri-Ess chapters, and Cross-Port, Crossroads, Paradise, and Transpitt.

We originally considered forming a Tri-Ess chapter in Columbus. When we got together in March, it became clear that Tri-Ess was not the answer. Tri-Ess has a policy allowing only "heterosexual cross dressers", meaning TV, but not TS or gay. Our group wished to be open. We have made some preliminary inquiries to Renaissance (an open organization) and IFGE (an meta-organization of affiliated cross-dressing organizations.) At the May meeting, we decided to affiliate with IFGE, and elected Susan our representative.

The latest Renaissance News contains the following item:

We received a letter from a contact in the **Columbus, Ohio** area about recent activities there.

A group of people, unrelated to Renaissance, got together in March to form a group in the area. A second organizational meeting was held in April. One of our contacts, Sandy [they mean Susan - MAH] was in attendance. She reports this new sisterhood is based on an open membership policy. They have not, however, asked to become a Renaissance chapter. Accordingly, we have deleted the Columbus listing from the *Chapter news and notes* column on page two.

We're very pleased to see people helping themselves and not at all concerned about their chapter status. We'll help in whatever ways possible. We wish them well.

The most recent Renaissance News contains several barbs at Tri-Ess, berating them for their "straight" policy. This text will be available at

the meeting for those interested.

The reason I have heard from Tri-Ess for their "straight only" policy is to protect the wives. Many of us are fortunate enough to have understanding, open minded wives and girl friends, who know what we are and what we are not. Unfortunately, many wives are hostile, or afraid their TV husband may be TS. It is difficult to get a wife to go to a meeting, or to participate in the culture. Many of the wives are reassured that their husband is TV by the fact that all the other cross dressers at the meeting are TV.

Tri-Ess generally does not mention other organizations (except for IFGE) in its publications. I found out about Renaissance and Cross Port from other Central Ohio sisters, after having been a Tri-Ess member for over a year. When writing for information, I was referred to Alpha Omega, but not told about Paradise or the closer Cross Port.

Personally, I would like to see Tri-Ess and Renaissance work together, and try to bring the community together, like IFGE does. I think there is a need for both open and straight groups. Cleveland has both Alpha Omega, a Tri-Ess chapter, and Paradise, an independent open group, and these groups cooperate and have many members in common. Why can't we all work together like these fine sisters?

Policies

The Crystal Club is an open support group for cross dressers. We welcome TV, TS, TG, and others who assume a complete feminine identity. We welcome their wives and significant others (SO's.) We welcome guests from other cross dressing organizations, when cleared through an officer.

We do not care about the sexual preference of the members and attendees. We do, however, require that all attendees behave like ladies at all times. Everyone has the right to feel secure, knowing they will not be ridiculed for their dressing or their appearance, and knowing they will not be "hit on" by anyone present.

We require that all attendees come completely dressed in feminine attire, or not dressed (i.e. in masculine attire). It is expected that most members will normally dress, but this is not required. Persons are *not* permitted to arrive

partially dressed, for example, a dress and male hair, or a dress and an unshaven face, as this may draw unwanted attention to the rest of the group. Ladies pants and casual wear are fine.

Meetings are open only to cross dressers who have been screened or approved by an officer, their wives/SO's, helping professionals, and approved guests. The location of the hotel is given out after the screening process, in order to protect our members from people looking for cheap entertainment.

Attendance Survey


