Maybe the Crystal Club can help to educate some of these USOs by designating a Significant Other Outreach Person (the SOOP? oh, please!) whose function is to talk to USOs and try to help them understand, accept, and enjoy sharing life with a crossdresser.

I'd like to try doing that. I like talking to people, and I certainly have no reservations (instead, I have positive feelings) about crossdressing itself, although I have had to give serious thought to some of its side effects (such as, what do we tell the kids?? Having dealt with some of those considerations may help me to relate to people who still have problems with some similar questions). I think crossdressers have a tough enough time that any really significant other should be supportive! And — I think SOs who don't appreciate crossdressing are missing out on a lot. I'd like to help crossdressers, and their SOs who are not yet supportive, to enjoy the difference that life has offered them.

The other jobs up for elections in this newsletter had descriptions in the last newsletter. The very concept of this job was just brought up at the last Crystal meeting, so its functions aren't yet well-defined. Another possible function for this job that we discussed at the meeting is to represent SOs to the Crystal officers. Personally, I don't think the SOs need this; we're all just as capable of speaking for ourselves, when we have something to say, as the (non-officer) crossdressers are. But if SOs want someone to represent them, I'm willing to do that (if I get enough input from other SOs!). If and when we vote, please make clear what you feel this job should cover.

I'd also like to make it clear that I don't want to campaign for this job against anyone else who would

like to do it! I am not convinced that I'm the best person to reach all USOs; if anyone else would like to do this, I'd encourage you to run or volunteer for this -- and -- if you do want me to do this, I DEFINITELY want help from any of the SOs who ARE supportive and comfortable with crossdressing. I think it's time the Crystal Club started providing more real support functions, such that we can overcome some of the obstacles facing crossdressers, and that SOs can help by reaching other SOs, and I'm willing to start working on that, but would like all the help I can get.

Book Review

"Transvestites and Transsexuals: Toward a Theory of Cross-Gender Behavior" by Richard F. Doctor: Plenum Press, New York, 1988.

No doubt, Dr. Doctor's book will be a long standing reference work on the topic. Future studies in the field will reflect his work. While Transsexuals are included, Doctor's work focuses mainly on theoretical understanding of heterosexual crossdressers. Trangenderism and homosexual crossdressing are addressed to a lesser degree.

Plan to read and reread this book. It is that rich. You can't get it all in one journey through its 234 pages. It is laden with statistical evidence supporting its conclusions... in a truly "scientific" manner. This, for a non-academic makes for heavy going. But it is penetrable. For example: Doctor supports, with the "numbers", a conclusion that 90% of all crossdressers are NOT GAY.

If you are of a "scientific" bent, you will find Dr.
Doctor's work very clear, cogent, and to the point. If you are not particularly "scientific" or "scholarly", it is still a rich source of information you can use in learning about yourself and others. More importantly, it is a book with the potential to provide you with the basis of a clearer, more fundamental understanding of yourself.... whether you are "scholarly minded" or not.

A professional in one of the "hard sciences", I had a lot of questions about "me" before reading Doctor's work. I have far fewer now. I had some obviously wrong conclusions about "me" before, now I'm certain I have fewer of these too. For example, I recognized five essential facts, as a result of reading Doctor's work:

- 1. I am not some sort of mental case.
- 2. I am not a "latent" homosexual.
- I am not less a "man", father, husband because I am a crossdresser.
- My being as I am, feelings and all, can be integrated into my everyday life. Crossdressing is not some sort of an island unto itself.
- 5. I am not alone in having these feelings and desires.

Acceptance of yourself as a crossdresser is a hollow victory, if you lose your marriage in the process. A separate chapter deals with the wives of crossdressers and their feelings. The contents of this one chapter are worth the price of the book. This chapter represents one of the very few times in print we are presented with the wives' side of the issue.

Recognizing and accepting myself as I am has been made far easier by reading Dr. Doctor's work. It may well do the same for you. I recommend it without reservation.

Crystal Club Cancellation And Refund Policy

Cancellation up to two days before an event: 188% refund. From two days until noon of the event day: 58% refund. After noon on the day of the event: no refund.

#### **Policies**

The Crystal Club is an open support group for cross dressers. We welcome TV, TS, TG, FI, and others who assume a complete feminine identity. We welcome their wives and significant others (SO's.) We welcome guests from other cross dressing organizations, when cleared through an officer.

We do not care about the sexual preference of the members and attendees. We do, however, require that all attendees behave like ladies at all times. Everyone has the right to feel secure, knowing they will not be ridiculed for their dressing or their appearance, and knowing they will not be "hit on" by anyone present.

We require that all attendees come completely dressed in feminine attire, or not dressed (i.e. in masculine attire). It is expected that most members will normally dress, but this is not required. Persons are not permitted to arrive partially dressed, for example, a dress and male hair, or a dress and an unshaven face, as this may draw unwanted attention to the rest of the group. Ladies pants and casual wear are fine. An adjacent changing room is available if you prefer to come in male clothing and dress at the meeting site.

Meetings are open only to cross dressers who have been screened or approved by an officer, and to cross dresser's wives/SO's, helping professionals, and approved guests. The location of the hotel is given out after the screening

process.

Membership is \$15 per year in advance. First year membership will run for 12 months from the date of payment. Second year membership will be pro-rated to run out at the end of the Crystal Club fiscal year, June 30. Additional years will be from July 1 to June 38.
