## **Meeting Locations**

In late November, several of the officers visited some potential new meeting locations. None is perfect, but each has its own advantages and disadvantages. Unfortunately, I can't name the specific sites in the newsletter, so I'll have to make up names for them. Any member in good standing can phone or ask at a meeting and we'll tell you where the sites are.

At the present time, we have four real alternatives. While we have committed to remain in our old location ("Site A") for the month of January, we may move at some later date. Your feedback is strongly invited.

Site A is our current site. It has the advantages of two attached dressing rooms, a good deal of privacy, and that we are familiar and comfortable with it. The primary disadvantage is that it is small. We have been growing lately, and it is awfully crowded to fit 30 people in this location. Inexplicably, however, our last few meetings have drawn about 20-25 people. It's still a bit crowded. We spend about \$130 each month here, plus the cost of food and beverages.

Site B is where we held the Christmas party. This site has plenty of room, and allows us to have dinner or snacks catered. There is a bar close by to supply drinks. We had a successful Christmas party there, and the banquet manager has been very kind. She has worked with crossdressers before and understands us well. The disadvantages to this site are the cost (we cannot bring our own food or drink, but must buy theirs),

the location of the dressing room (a bit of a walk away) and the presence of a bar that draws other local residents. Some members have expressed concern that someone at the bar may recognize them. The bar draws older people with oldies bands on weekends. A police officer is on duty every Saturday to prevent trouble, and as a result there hasn't been any trouble. In addition to the \$50 dressing room charge, the banquet room alone costs \$150, but if we have dinner or snacks there the price is reduced to a \$25 setup charge. Food costs anywhere from \$6 to \$18 per person, and beverages run from \$1.25 for a soft drink to \$3.50 for a mixed drink.

Site C is a private lodge in a public park. The lodge is very nice and quite roomy. We can bring our own food – it has a large kitchen. The location is well shielded from the rest of the park, although an occasional hiker might wander by during daylight in the summer. A park ranger will be around to ensure safety and security. The cost is quite reasonable, ranging from \$65 to \$115 depending on the season and how late we stay. The disadvantages are that no alcohol is allowed under any circumstances. We must be gone by midnight (with a big discount if we are gone by 10:00; the difference pays for overtime for the ranger). There is no dressing room, although the bathrooms are both roomy and private, as is the kitchen.

Site D is a rental hall owned by the Lions Club. It costs \$115. It is large but has a bare concrete floor and gravel parking lot. Food and alcohol are allowed. We have to allow any Lions Club member admission at any time. When we set up an appointment for 4:00 to see the site, we arrived at 4:04 and found nobody there. A phone call to the renters determined that they were unwilling to come back to show it to us.

It is also possible that additional sites will turn up. We have thought of renting a hospitality suite in a hotel. If a rich relative would die and leave one of us a large check, that person could buy a secluded house in the country and allow us to meet there. Please be on the lookout for better meeting locations.

Until our membership grows or tells us that we are too crowded in Site A, we will probably stay put. However, if we do grow, we may have to move quickly. If you have a preference, let us know now. It's only a matter of time before we burst our current site at the seams.

## **Editor's Edict**

Ladies, this is your newsletter. It's beginning to take on a life of its own, so it's important for you to tell us what you want it to be. Most importantly, this is a forum for you to say what you think, or what you feel. Tell us what's going on in your life! Tell us what you like or don't like about the club, the meetings, or the newsletters. Tell us what you want and what you don't want. If you put it in writing, your views will be taken more seriously than if you just tell one person, because everybody will hear you.

I'd like to say a big thank you to Adrianne, Jennifer, Lana, Rochelle, and Susan for this month's contributions. Beautiful stuff, ladies!

The newsletter also has a lot of other material. We cover the news, try to stir up interest in political issues, work for good community relations with other gender groups and local individuals and groups who have been supportive. Advertising helps you find a place to shop or buy that special product or service that you can't find at K-Mart. Listings for neighboring groups help us make friends in nearby cities, and refer new inquiries to the closest possible groups. Articles shamelessly stolen from other newsletters and publications let a wider audience read the excellent writings of others. (I'm sure some of you can write some amusing prose, too!) Fiction makes entertaining reading.

All of this comes at a cost. Your \$15 annual membership dues is intended to cover the cost of the newsletter. Once upon a time, when the newsletter was 4 pages long, it did. Now that we're getting into thicker newsletters (anything over 10 pages takes two stamps) our copying and postage costs per newsletter are more.

We also exchange newsletters with many sister organizations (which, besides helping us make friends, allows us to reprint their articles.) We build good community relations by including our local friends on our courtesy mailing list; people like Nancy, Sylvia, Gloria, Michelle, Dr. Crane, have been wonderful, and local groups like Stonewall Union, GLBS, and NOW have helped a great deal to bridge the gap to the general community. Advertisers also receive a subscription to the Chronicle. Our current monthly mailing includes 28 courtesy copies of the newsletter, in addition to our 37 members, and about 5 sample newsletters to prospective new members.

Our cost to print and mail a 10 page newsletter is about \$10.80/copy/year, or \$750 at our current size. Our 37 nembers' dues add up to \$555. If the newsletter is 16 pages, he annual cost is about \$17.50, or \$1225 total. These prices work out to \$20.00 per paying member for 10 pages, or \$33 or 16 pages. These costs assume the newsletter editor puts in intold hours of volunteer work — we couldn't even begin to afford to pay someone to do this!

The newsletter has grown by leaps and bounds since it /as started. The number of pages in the 1989 newsletters /ere 4, 5, 4, 4, 8, 8, 6, and 20 pages in the December issue at included the entire Renaissance newsletter. The 1990 ewsletters have been 8, 8, 8, 12, 10, 10, 10, 10, 12, 15 and 12 ages long. It is clear that our newsletter has outgrown our

\$15/year membership dues.

We would like to offer more member services than just the newsletter. Rather than having stick-on name tags, we are considering nice pin-on name tags with members' names and possibly our logo printed on them, at prices ranging from \$1 to \$9 each, depending on how nice they are. The telephone line is important, too, and incurs a monthly charge.

We need your feedback. Should we cut back the newsletter to last year's size and stop exchanging newsletters with our neighbors and friends? Should we raise membership dues to cover the costs? Should we invest \$1000 in a copier, which would pay for itself in about 2 years, but require higher dues for those two years? Should we reduce our mailing costs by sending a folded and stapled newsletter at bulk rate instead of a sealed envelope at first class rates? (There are privacy issues here, and it would take longer to arrive.) Should we raise our meeting fee about \$3/month to cover the extra cost? Should we reduce the newsletter to half-size with little teeny print to reduce the number of pages? [Pages 7-10 of this newsletter have been reduced to illustrate what I mean. Imagine all 12 reduced and folded down the middle like a booklet. While the laser printed pages look pretty legible, I printed page 8 on a dot matrix printer so you can see what it looks like reduced.1

Tell us what you want. Send in an article to air your views. If you can't do that, at least corner me at a meeting and let me know. Our new newsletter editor (effective in March) will have to make a lot of decisions about the newsletter, and will probably use a different process from the current newsletter. We don't know if the use of a laser printer will be possible. Please help her provide the newsletter you want, at a cost you are willing to pay for.

## Skirting the Issue

Should a man who stays home to take care of a child while his wife works be allowed to join a mothers-infants group?

This is not as difficult a question on child-rearing as the one Solomon once had to settle, but intriguing nonetheless.

Fairness in an age moving toward unisex would seem to dictate that Joel Chaiken could join the Riverdale NY Neighborhood House support group. But Chaiken found a closed door. So he has filed what may be a precedent-setting discrimination suit, which one might expect in a nation where even the tiniest, silliest misunderstanding winds up being litigated.

The New York State Division on Human Rights recently

decided Chaiken's case has merit and has ordered a public hearing.

Some in Riverdale's upper-middle-class neighborhood, about 11 miles north of midtown Manhattan, say they wouldn't be comfortable with a man in the group.

"There are mothers and there are dads and he's not a mother," said Caryl Malka, 33, boiling the argument down to basics.

Isn't that the kind of thinking that feminists are trying to do away with?

Chaiken is a parent staying home to take care of a child while the other parent works. The group was formed to be a forum for just such people. To rule otherwise would be sexist, wouldn't it?

Just because Chaiken doesn't wear a skirt is no reason to exclude him. Just as there is no reason to keep a woman from formerly male bastions just because she wears a skirt.

[I'll bet if Chaiken wore a skirt to the group meetings he'd be the only one doing so. But maybe he just doesn't have the legs for it.]

## Police Force Woman to Drop Pants

Two female bodybuilders have filed a \$1 million police misconduct claim against the city of Costa Mesa, saying officers forced one of them to drop her pants to prove her sex.

Lorie Sencer, 28, and Bridget Morton, 20, were stopped by police about 9 p.m. Oct. 27 as they were coming out of the women's restroom at the Pacific Amphitheatre, their attorney, John Duran, said Monday. The two were attending a Billy Idol concert, Duran said.

Sencer, of Los Alamitos, said four officers blocked the restroom exit as she and Morton tried to leave. "The one officer said that we would have to go to jail unless Bridget showed him some kind of proof that she was a woman," Sencer said. "He told her, 'Let's go around the building there and see.'"

When the women protested, the officers ordered the amphitheater's first-aid and security officials to examine Morton, Sencer said.

"They took her in the first-aid tent and made her drop her pants," Sencer said. "Then the first-aid lady yelled out, 'She's a woman.' The police officers just took off."

Rick Graves, the head of medical and safety operations at the Pacific Amphitheatre, confirmed that police ordered his staff to inspect Morton's genitals.

## **Pioneering Woman had Columbus Ties**

Mary Edwards Walker was the first woman to win the Medal of Honor. She was a tireless worker for women's rights and a battleground surgeon during the Civil War. She led the fight for women's right to wear pants.

Born in Oswego, NY in 1832, Walker received a physician's certificate from Syracuse Medical College in 1855. She began her practice in Columbus and then moved it to Rome, NY.

During the Civil War, she served as a nurse in the Union Army until 1864, when she was commissioned and made a surgeon, the *Encyclopedia Americana* says.

That year she was captured and held for four months in a Confederate prison. She was finally exchanged for a confederate officer.

In 1917, a federal review board revoked her Medal of Honor, claiming she had never actually served in the Army. She continued to wear the medal, in spite of the revocation, until her death on Feb. 21, 1919. The Army restored the medal in 1977.

After the war, Walker was a leader in the movement to end restrictions on the way women dressed, *The World Book Encyclopedia* says.

She believed women should be able to wear whatever they want, and she took to wearing men's clothes such as pants, coats, bow ties and top hats to make her point. In the army she had worn a uniform like other officers.

She wore men's clothing during the daytime but sometimes changed into evening dresses when she was lecturing on social reforms.

The book *Notable American Women* said Walker was small and slender and attractive. She married Albert Miller, a medical student, but never adopted his name. They divorced in 1869.

Walker also campaigned for women's right to vote, but in her later years she became so eccentric even other suffragists distanced themselves from her and her unpredictable behavior.

A commemorative stamp was issued in 1982 to celebrate the 150th anniversary of her birth.

## Policies

The Crystal Club is an open support group for cross dessers. We welcome TV, TS, TG, FI, and others who assume a complete trans-gendered identity. Both Male-to-Female and Female-to-Male individuals are welcome. We welcome their spouses and significant others (SO's.) We welcome guests from related organizations, when cleared through an officer.

Meetings are the fourth Saturday evening of each month. Meetings are open only to cross dressers who have been screened or approved by an officer, and to cross dresser's spouses(SO's, helping professionals, and approved guests. The location of the hotel is given out after interview.

There is a monthly meeting fee (see schedule below) to cover the cost of the room, food, soft drinks and coffee, and general operating expenses of the group. This fee is above and in addition to annual membership dues. If you wish beer or wine, BYOB (many people do.)

Nonmembers may attend as many as three meetings before joining. Usually a new member will join at their first meeting, paying a total of \$30 (\$35 for couples) at that meeting.

We do not care about the sexual orientation of the members and attendees. We do, however, require that all attendees behave like ladies or gentlemen at all times. Everyone has the right to feel secure, knowing they will not be ridiculed for their dressing or their appearance, and knowing they will not be "hit on" by anyone present.

We require that all attendees come completely dressed as the gender they are presenting, i.e. entirely as a woman or entirely as a man. Members will usually dress, but this is not required. Persons are *not* permitted to arrive partially dressed, for example, a dress and male hair, or a dress and an unshaven face, as this may draw unwanted attention to the rest of the group. Ladies' pants and casual wear are fine. An adjacent changing room is available if you prefer to come in male clothing and dress at the meeting site.

Membership is \$15 per year in advance. After the first complementary copy of the newsletter, additional newsletters are sent only to members who have paid their dues. First year membership will run for 12 months from the date of payment. Second year membership will be pro-rated to run out at the end of the Crystal Club fiscal year, June 30, rounded to the nearest \$5 (4 months.) Additional years will be from July 1 to June 30.
