

New prospective members must be screened by the Member Representative or another delegated repetitive of the Crystal Club. We do not discriminate on the basis of sexual orientation, race, creed, or age of the members and attendees. We do, however, require that all attendees behave like ladies or gentlemen at all times. Get Set to Tell Electrologists So Long Classification for hair removers is about to be phased out

Electrologists are going the way of the dinosaur in Ohio.

Electrologists are professional specialists in body and facial hair removal with electronically charged needles.

The Ohio general assembly is on the verge of enacting legislation placing the state's 313 licensed electrologists back under the regulation of the state Medical Board, along with other cosmetic therapists.

The classification of electrologist is to be phased out in 15 months.

House Bill 322 cleared the senate yesterday (Oct. 30th), 30-1, and was

returned to the house for concurrence in changes. The House passed it unanimously in June.

Seven years ago lawmakers, convinced of an impending boom in the electrology business, voted to reduce the training requirements and place the professional hair removers under the state Board of Cosmetology.

"The demand never showed up," said Patrick G. Kevs, executive director of the cosmetology board. "I guess women just didn't want to get their hair tweaked out."

More than 6O percent of the electrologists are licensed cosmetic therapists anyway and they need the dual license only to practice in a beauty parlor, keys said.

Sen. Merle G. Kearns, R-Springsfield, floor manager of the new legislation, said it will eliminate duplication and upgrade education requirements. The requirements

were lowered to 150 hours in 1984 to attract more people to become electrologists. The legislation calls for a return to 600 hours.


Keys said most of the 124electrologists without a cosmetic therapy license have 600 hour of training or are well on their way to it.

Electrologists may continue practicing until Feb. 1, 1993. Then they must be licensed cosmetic therapists.

"We're real happy that we're all going to be on the same wavelength," said George Dunigan, representing the Ohio Cosmetic Therapy Association.

The bill also adds two members to the cosmetology board and allows it to regulate estheticians -- advanced skin care specialists who use body wraps and toning boards for clients.

Expert Urges More Discussion on Gender Bias Issue

Last month's Senate hearings into sexual harassment charges against Clarence Thomas and the Florida rape trial of William Kennedy Smith could help Ohio women win more equitable divorce settlements, a national expert on sex discrimination said yesterday (Oct. 31st).

Lynn Hecht Schafran of New York City urged members of an Ohio task force on gender fairness to use public interest in the rape trial and Thomas' confirmation hearings for the U.S. Supreme Court to generate discussion on the more subtle issue of gender bias.

The task force, appointed jointly by the Ohio Supreme Court and the Ohio State Bar Association., held a daylong seminar at the bar association offices in Columbus to examine gender bias in the legal profession and talk about how to fight it.

Drawing the line between sexual harassment and sexual bias can be difficult, said Justice Alice Robie Resnick of the Ohio Supreme Court, a founder and co-chairwoman of the task force.

The problem with sexual bias in the courts is that it can result in lasting damage, without those who are inflicting the wounds even realizing what they are doing, Schafran said.

Gender bias can come in several forms. ranging from demeaning treatment of women lawyers to unfair judgements for their clients, he said.

Judges may not even realize they are showing their bias when they fail to recognize the contribution a woman has made to a marriage as homemaker.

"To say to a judge, 'You may be biased,' is telling them, 'you are not doing your job.' It is very difficult," she said.

Some states, such as California, require judges and lawyers to participate in education programs on gender fairness.

Resnick said she favors a more subtle approach, such as working the issue into required courses on ethics.

The task force is gathering data for a report. Schafran urges members not to wait until the report to begin trying to change attitudes.

Once people start examining the issue, they often are amazed to learn "we aren't where a lot of people thought we were," Schafran said.

For example, she said she heard that one of Ohio's oldest law firms recently named it's first female partner, and woman candidates for judge still get asked, "Who's going to take care of your children?"

"This is not information from vestervear. I hear this all the time," Schafran said.

The Ladies' New Clothes Shouldn't be Gentleman's

It is high time Miss Manners ordered some new clothes. Oh, not for herself. Her fashion interest at the moment concerns the need to establish a standard of dress for ladies in official positions.

Not all ladies in the business world need to be distinguished by their dress, any more than all gentlemen do. A simple adherence to the dress customs of the time and of the particular job are all that is required.

Not that this came easily. Both employers and the workers themselves had to be wrenched away from the idea that ladies should always look as if they were appearing for social purposes. Some silly supervisors were demanding that their workers wear skirts for serious labor and were puzzled about why they were encumbered in doing the job. Other supervisors were showing up in frills for serious business and were puzzled about why they weren't treated seriously.

The difficulty is to find something that

is both professional and feminine, a stylistic concept that Miss Manners does not care to define beyond saying that she rejects the idea that, in order to look competent, ladies should have to dress like gentlemen.

This is now what is being done with, for example, waitresses in expensive restaurants. One sees people of both genders working in formal restaurants. But the waitress generally wear masculine evening clothes, as if they had to made honorary males in order to qualify for the job.

For manual labor, male and female costumes are nearly identical; for

dress-occasion jobs, a lady's suit or dress is obviously equivalent to gentleman's suit. The military and other organizations requiring uniforms have, on the whole, done a good job of adapting their uniforms, but their evening uniforms smack of the pseudo-masculine.

What still is needed is a female equivalent of formal clothing to be worn professionally. It should be practical and durable -- so that one can wear the same thing over and over again -- but not masculine.

Virginia's Secret Told

Group unveiled by writer in drag From USA Today

Richmond (Va.) Times-Dispatch readers recently got a shock when the newspaper ran a feature on a local group of male cross-dressers known as Virginia's Secret.

What they didn't know were the lengths reporter Mark Holmberg went to for his story.

Holmberg who stands almost 6-foot-9. interviewed Virginia's Secret members while wearing size 15 heels, queen-size panty hose, a camisole, a skirt, a jacket, a wig and makeup.

"Everyone was so busy laughing at me or congratulating me or wondering if I was a closet queen that they sort of forgot I was a reporter. My casual interviews automatically became intensely personal and revealing," Holmberg writes in an employee newsletter put out by Media General Inc., parent of the Times-Dispatch.

Newsroom reaction was divided, he says. "Women seemed to think it was a gutsy thing to do. Men thought it wasn't such a good idea."

Holmberg, 35, is reluctant to talk about the story. "I don't want to be known for putting on a woman's dress. I want to be known as a good reporter."

The following is lifted from a women's studies list. I'd like to hear comments from the guys' point of view concerning the advantages and the disadvantages of having boytoys and boygames thrust upon us, and/or the advantages/disadvantages of being deprived of being able to play girl... This topic is hardly bordering on non-academic!! Socialization of girls and boys is a major part of many women's studies and sociology classes. (also anthropology and psychology and some philosophy, I suppose!).

Toys and games are central to the learning and reinforcement of sex-roles. Appropriate and non-appropripriate behaviors are learned more quickly through toys, games, and sports that almost any other factor. There is a large body of research on toy/games/sports and socialization that can be used in the presentation of materials on socialization. Students relate very quickly to this approach to gender role socialization because many of the men remember being punished or at least scolded for wanting to/or playing with 'girl' toys - especially dolls. Women remember the disappointment of not getting the baseball and glove - but instead another doll, or being unable to play with her brother's truck or racing car track (that was my biggie!!). Students with children can also easily relate to this topic by observing their children's wants and what kids will do with siblings that they would not be caught doing in public!

Boy toys and girl toys contribute to a number of factors that can be addressed. Boy toys are generally more social, require more physical space and motor ability. Boy games generally have more 'roles to play or parts' that keep boredom away. They also have a high skill ceiling meaning that the game can be played and the players improve their skills sometimes for years. Girl toys are generally more solitary, require turn-taking as opposed to parallel or head-to-head competition, require little space or motor ability. Girl games have a low skill ceiling and it is easy to get bored quickly playing girl games/toys. Also, when boys play boy games, because they require more people, little boys learn to develop skills quickly because they are force to 'play up' to the bigger boys' skill level or be left behind. Girls have a tendency to 'play down' to younger children thus limiting their own skill development (except possibly in child-care activities) and the development of the younger children.

Solving disputes between children takes a different tack to for boys and girls. This relates directly to the toys andgames they play. Boys fight and argue about rules and calls, but generally 'do it over' after a while so the game can continue. Girls fight - and the game breaks up. generally this is because girl games get boring quickly - there is no excitement - so there is little need or desire to fight for the contination of the game.

When I write of girl toys/games or boy toys/games, I am not necessarily suggesting that these are exclusively what boys and girls do. These are just some of the characteristics of 'gender appropriate' toys/games. The toy manufacturers and the advertisers develop and push toys specifically for boys and for girls. They understand peer pressure and parental bias! Consumer action has worked in the past to get some changes. For a while war toys were less available and certainly less lethal! But since the gulf war was so popular - war toys are back and probably will be for some time to come.

Hormone Cycles Affect Men's Test Results

When psychologist Doreen Kimura reported three years ago that women's performances on standardized tests vary with their hormonal cycles, she was roundly criticized for her "sexist" attitude. Critics charged that her results reinforced the idea that women could not handle certain jobs because they were prey to their emotions once a month.

Now, however, Kimura has closed the loop by finding the same sorts of hormonal variations in men's performances on the tests, suggesting that they, too, are captives of hormones.

Researchers have long recognized that women perform better than men on some types of standardized tests, such as those that measure muscular coordination and verbal facility. Men score better than women on certain other types of tests, including those involving spatial reasoning, such as the ability to imagine the entire shape of a three-dimensional object when presented with only one view.

Kimura, from the University of Western Ontario in London, Canada, created a stir in 1988 when she reported that women's results on these tests varied throughout the month. She found, for example, that their scores on tests of muscular coordination and verbal facility increased by as much as 10% during the times of the month when their blood levels of the female hormone estrogen were high.

Similarly, their scores on tests of spatial reasoning dropped when blood levels of of the male hormone testosterone were reduced. (Women have small amounts of male hormones in their blood and men have small levels of female hormones.) Her studies of young men had also shown a curious link between testosterone levels and spatial reasoning ability. While females with above-normal testosterone levels score higher than other females on spatial reasoning tests, males with below-normal levels of the hormone also score higher than other males.

"It thus seems that there is an optimum testosterone level that is intermediate between the levels in males and females," she said in a telephone interview. To test that theory, she studied changes in test scores related to hormone levels in men.

Previous research has shown that men have a yearly hormone cycle. Testosterone levels are, ironically, lowest in the spring "when youn mens' fancies turn to thoughts of love," Kimura said, and highest in the fall. Kimura and her colleagues administered three different groups of tests to 36 males and 36 females in March, and the same tests to another group in October.

The tests included those on which women normally do better, those on which men normally do better and a third group of gender-neutral tests.

She found that the women performed at the same level on all tests in the spring and the fall and that the men performed at the same level on the gender-neutral tests. But the men performed as much as 25% worse on the tests of spatial reasoning in the fall, when their testosterone levels were highest, and

somewhat better on the tests of verbal

Locker Room Policies Biased Against Men

For instance: Major League Baseball, the National Football League, the National Basketball Association, the National Hockey League, the Professional Golfer's Association and the Major Soccer League all have locker rooms open to male and female reporters.

The Association of Tennis Professionals (for men) and the Women's Tennis Association both ban reporters from locker rooms.

The Ladies professional Golfers Association tour bans all reporters from locker rooms.

The U.S. Tennis Association allows reporters in both men's and women's locker rooms, although men rarely venture into the women's locker room.

The U.S Golf Association allows reporters to go into the men's locker rooms but bans them from the women's locker rooms.


Three Boys Wearing Earrings Suspended by Alabama School

SALEM, Ala. (UPI) -- The rural Alabama high school's administrators gave the boys a choice: either the earrings or they must go. Three boys went.

The earring-bedecked youths were suspended from West Limestone High School after the taunts and questions of other students disrupted classes, the school principal said Wednesday. Principal Aubrey Privett said two boys were disciplined for violating a dress code and the third was punished for disrespect.

Anime May Be For You

Dear People,

You've no doubt heard of RANMA 1/2 on this list before. It's the Japanese animated TV show wherein the title character turns into a girl whenever cold water is splashed on him, and a boy again when hot water is applied. I'm here to tell you where you can get subtitled VHS video- tapes of the first five episodes. . . for cheap. But first . . . I think that I should explain that this show does not glorify cross-dressing or transgenderism. The character that changes into a girl generally does it only under protest. This ability of his is both figuratively and literally understood as a curse. So, those of you who thought they would be interested in this item might want to rethink trying to track it down. It's somewhat like the movie SWITCH, with Ellen Barkin, in that being female and/or feminine is seen by the main

character as undesirable.

That said, here is a rough description of the show: a boy and his father go to practice martial arts at a site considered very dangerous to fool around in. The tour guide tries to tell them about the dangers of the mystic pools at the site, but the two are impatient and start right in fighting. As the guide says, this site is made up of a few hundred pools where various people and animals died. Whoever falls into one of them will forevermore assume the form of the entity that died there whenever he, she, or it comes into contact with cold water: Ranma and his father are fighting atop wooden poles jutting over the surface of one of the pools and are too absorbed with what they're doing to heed the guide. Ranma succeeds in dismounting his dad, who falls into the pool, but he himself looses his balance and careens into the pool next to the one he was just straddling. His dad is transformed into a giant panda, and Ranma himself comes out a girl -- actually, a princess who died in that pond thousands of years ago.

From here, the story details how Ranma is matchmade to one of his father's friend's daughters. The thing is, this man and his three daughters are also martial artists. In short order, they find out about Ranma's peculiarity. The feistiest daughter, Akane, is selected to marry Ranma, but she hates boys. It turns out that every school day begins with her fighting 20-odd boys (all at once!) who want to date her, so she hates them all. Even worse, Ranma-chan (the female version of Ranma) has a nicer body than her, and gains the attention of the high school's best athelete/martial artist, who falls in love with Ranma. Ranma/Ranma-chan is an ace martial artist who can beat both this guy and Akane.

Much of the comedy in this series comes from its various love triangles. The original RANMA 1/2 comics that this show came from are written by Japan's top comic writer/artist, Rumiko Takahashi--who is a woman! The show is targeted at 4-to-8-year olds in Japan, so it's a little surprising to see breasts touched and exposed (although not at the same time), but hey, things are different over there what with communal bathing and all.

If any of this hasn't dissuaded you from seeing this stuff, you might want to get a copy of the first 5 episodes from Pat (it's Patricia, actuall) Munson-Siter. Time for another warning: these tapes she has are third generation copies of fan-subtitled versions of the shows. There- fore, the visual quality is not what one would call optimum. The sub-titles are fully legible, and the picture quality of the animation is fairly good, but don't expect the quality of a store-bought or rented tape. On the other hand, this is the only way you will ever get to see translated versions of this show. They can be obtained as laser- disk imports (from Japan, naturally) in Japanese, but otherwise, you

can only get them through Japanese animation fan clubs and tape traders like Pat. NOTE: Pat is a fan of Japanese animation, not cross-dressing or

Here's a problem most of us have had at one time or another.

Dear M.

I've been crossdressing for sometime now, but I still find I'm really paranoid about going out in public and I feel especially vulnerable while trapped in my car driving to my support group meeting. Will you advise me on travel tips?

Dear CCCC,

Most CD's fear being "read" while out, but most I know feel pretty secure locked securely in their vehicles. Some helpful hints will give you more confidence.

Keep in mind our Newsletter Editor's philosophy; "People see what they believe they see."

Keep in mind my philosophy: "People don't believe what they've seen, but by the time they do... you've turned the corner."

In keeping with this philosophy, always travel in the right hand lane so you can turn off quickly if there's a problem. You've probably noticed that you always get cut off at lights and are thus first in line.

Others in the four lanes on either side of you always pull up even with you and of course you believe that they're checking you out and laughing their tushes

off. Actually they are waiting, like you; to see when, if ever, the light will change, except that it's not quite the eternity for them that it is for you. So, always leave some space in front of you so you can drift ahead if anyone tries to pull up even with you.

Secretary Speaks by Adrianne

In the two years since the formation of the Crystal Club, hardly a week goes by where a daytime talk show, or night time television series, doesn't present or discuss some aspect of crossdressing. We enjoy having the spotlight on our cause, but unfortunately, we are most often presented in a "sensational" manner, and treated as being rather bizarre or worse! The idea behind the creation of the Crystal Club was to provide an environment where we could express (dress) ourselves and have the support of other people with the same proclivity. The other major function of the club is to educate ourselves and the general public about crossdressing, who we are and what we are.

"Why?" is the question that is asked first, but it has no importance to those of us that have reached self acceptance and like who we are. We would still like to know "why" but only in a scientific curiosity, we exist, and have no desire to be cured if such a thing were possible.

We are your neighbor, your mechanic, your baseball coach; I am a father, a brother, a husband; we go to church, PTA meetings, concerts and movies. The question is, do you know me when you see me? I have told you who and what

I am, and some people are offended or even threatened by me being a crossdresser, but most of the time when I am out in public presenting the opposite gender, no one knows! Reaching this point in my life has not been easy, I have spent 30 of my 40 years trying to make peace with myself. Finding the Crystal Club provided me with an avenue to openly express myself, dress, in front of other people with the same gender identity problems. I have had only a couple friends throughout my life, mostly just acquaintances. Now I several friends who know more about me than my immediate family, and accept me as I am. Also for the first time in my life I have a social life: club meetings every month, I go shopping at the malls, to the theater with my wife, out to restaurants, all as "she." I do not do this to show-off, because by becoming feminine, I also take on all the other risks that a woman lives with - I can not walk alone at night on city streets. I get followed in the car, I receive

This requires a substantial amount of courage, as most of have spent many years of our lives trying to deny who we are. Most of us have surprisingly similar life experiences which we have had to overcome to be able to like ourselves and feel whole. Personally I have had emotional problems, low self esteem, ulcers, a broken marriage; while others have had years of counselling, terminated employment and physical and mental abuse. Many people reading this may think, "what a bunch of sissy wimps." They're right! We are sensitive and caring, and have a very pronounced feminine part of our being. We enjoy feeling pretty outside and beautiful inside, and our crossdressing is the major avenue to get in touch with our feelings and become our true self.

The gender community is mostly shielded form the general public, not many of us openly espouse what we are, and we can not go out an recruit members like the Lions club. Those people still hiding in their clothes closet, must find their way to us. We are attempting to get more publicity and increasing our educational efforts. We want central Ohio to know that the Crystal Club exists, and we are striving to promote our message that we are not handicapped, perverted nor mentally disturbed; we are unique individuals who only request tolerance of our difference and acceptance of our right to self expression.

Vocal Techniques for Crossdressers

Your six feet, six inches tall, weigh 280 pounds and play middle linebacker for the Chicago Bears. When you talk your voice sounds like it's coming from the bottom of Carlsbad Caverns. Can you learn to speak like a woman well enough to fool Mike Ditka?

Probably not, according to Wendy Parker, who presented apopular seminar in the House of Commons room entitled "Speaking In a More Feminine Manner." However, Parker doesfeel "confident that any male crossdresser or transsexual who desires to develop a more feminine speaking voice can do sousing proven techniques and without the controversial surgery to shorten the vocal cords."

Parker, a noted musician, advised her listeners to speak with the musical scale in mind. "There is a tendency for us (men) to try raising our voices a full octave when we want to imitate women's speech. But that's too much and it puts our voices into the falsetto which sounds phoney," Parker stated. Continuing, Parker advised using a range of three tones up and three tones down the scale to create the musical quality which is common in feminine vocalization.

Other hints for better feminine speech included ending sentences with a raised inflection; using hyperbole in speech (That's a lovely jacket you have on); using more expressive gestures while keeping the limps close in; leaning forward and establishing good eye contact; talking about subjects offeminine interest, e.g. relationships, clothing, children, cooking; talking in the mask, i.e. "talking forward in the mouth and using the lips rather than letting the sound come from deep in the chest."

Parker advises reading "You Just

Don't Understand" by Deborah Tannen (Morrow Press, New Your, 1989) for those who wish to pursue feminine vocalization in greater detail. Parker's best advice to those who would speak more femininely was to adopt a female role model and study her vocal habits. This can be done with the aid of audio recordings, or preferably video recordings, as feminine speech encompasses facial expressions as well as sound. Parker said her feminine voice model was Sigourney Weaver, Listeners agreed that Parker had, indeed, succeeded admirably in mimicking her vocal idol. Now if she can only learn to emulate Weaver's body.

Man held in alleged attack on CD prostitutes

(West Hollywood, CA) — A Santa Ana man who allegedly fired several shots at two crossdressed prostitutes in the early hours of September 29 was being held without bail on suspicion of attempted murder and civil rights charges, authorities said.

The attack took place about 3:40 a.m. on Santa Monica Boulevard, according to Los Angeles County Sheriff's Deputy Irma Becerra. Ruben Velasquez, 29, approached the men -- one of whom was wearing an orange dress, a denim jacket and high heels -- and allegedly uttered the threatening epithet "I'm going to kill you queens," just before firing three or four times at them, Becerra said.

A deputy from the sheriff's canine unit who was patrolling nearby heard the shots, saw a muzzle flash and spotted Velasquez running to a station wagon, Becerra said. The deputy pursued

Velasquez and found a .25-caliber semi-automatic pistol inside his car after pulling him over.

Velasquez was booked on suspicion of attempted murder and interfering with a person's civil rights. Anti-gay statements Velasquez allegedly made to arresting deputies led to his being booked on the civil rights charge.

Sheriff's Sgt. Tony Hollins said both victims attack are known gay hustlers."They are actual male prostitutes, dressed in female attire," he said. However, he said neither has been arrested by the West Hollywood station's Special Problems Unit, which makes arrests for prostitution in the city.

The men, both Los Angeles residents, ran west along Santa Monica and either "fell or dove for cover" as the shots rang out, Becerra said. Their only injuries were cuts on their knees.

TS tied to crime scene in mexico murder

(Phoenix, AZ) — An assistant Arizona attorney general says "physical evidence" has been obtained placing a transsexual suspect at the scene of the murder of a Gilbert, Arizona woman February 23. Mitchell said that Yesenia Gonzalez Patino, 35, who was known as Alfredo Patino before he underwent a sex-change operation in Colorado 10 years ago, had a "strong romantic relationship" with Dan Willoughby, the victim's husband. Willoughby has been questioned but not charged with any crime.

Patricia Willoughby, 42, was unconscious when she was found by her husband at their rented condominium in Puerto Peñasco (Rocky Point), Sonora, according to law-enforcement authorities there. The victim, who had been stabbed several times in the face and neck, died later at a local hospital.

While refusing to elaborate on the evidence, Mitchell said that located Patino is a key to the case. She is believed to be in Arizona or Mexico and to have retained her female identity. "If we find Yesenia, it will be the end of a successful investigation and the beginning, we think, of a successful prosecution," Mitchell said. He said his office is involved because it appears there may have been a murder conspiracy that began in Arizona.

The victim's mother told reporters she has added \$5,000 to a \$1,000 reward fund that already has been offered through the Silent Witness program of the Phoenix Police Department for information leading to Patino's arrest. [Arizona "Republic"]

Sex-identity theorist Dr. Robert Stoller dies

Stoller, a leading psychoanalytic theorist on sex-identity problems and perversions, died September 6 in a traffic accident outside his home. He was 66.

Dr. Stoller was killed as he pulled out of his driveway and his car was struck by another car in Pacific Palisades. He died instantly from injuries in the crash.

Best known for his writings on perversions, sexual excitement and sex-identity problems such as transsexuality, Dr. Stoller's theories "shook some fundamental beliefs of the psychoanalytic establishment," said Dr. Ethel Person, a psychiatrist at Columbia University medical school.

Dr. Stoller set forth his theories in a series of influential books, including "Sex and Gender: On the Development of Masculinity and Femininity", published in 1968, and "Presentations of Gender", published in 1985.

Dr. Stoller was educated at Columbia University, received his bachelor's degree from the University of California at Berkeley and his medical degree in 1948

from the University of California at San Francisco. He joined the psychiatry department at U.C.L.A. in 1954.

He is survived by his wife, Sybil, who was in the car with him at the time of the accident but suffered only minor injuries, and by four sons. [N.Y. "Times"]

Preliminary program schedule set for 1992 **IFGE Convention**

(Houston, TX) -- A preliminary listing of programs has been announced for the 1992 International Foundation for Gender Education (IFGE) "Coming Together -Working Together" convention.

Seminars have been tentatively planned in the areas of leadership, education, business, as well as eight seminars oriented specifically toward newcomers to the gender community. A three-day program dealing entirely with transsexual issues has been scheduled, as well as a two-day program on female partners' issues and a two-day program run by mental and medical health professionals for other professionals. Specific details will be announced by IFGE as the convention date draws nearer.

The convention, co-hosted by Texas gender community organizations Gulf Coast Transgender Community, the Tau Chi and Delta Omega chapters of Tri-Ess, Boulton & Park Society, Heart of Texas Gender Alliance, and Women Associated with Crossdressers, will be held April 6 through 12. Aggis announces formation of advisory board

(Atlanta, GA) -- The Atlanta Educational Gender Information Service (AEGIS) has announced the formation of an advisory board and a gender support group. The advis of researchers, service providers and transgendered persons, many of whom are nationally known. AEGIS has issued an open invitation to anyone interested in serving on the board.

The support group, open to all transgendered persons, meets monthly in the offices of a counselling professional in the Atlanta area. Issues of self-discovery, role exploration, and practical concerns will be addressed in the group, which will also feature guest speakers. AEGIS has also initiated a series of of public service advertisements addressing gender community consumer issues, including the dangers of extremely high dosages of hormones and the injection of liquid silicone into the human body. The advertisements are being distributed to service providers and gender organizations internationally. [AEGIS press release]

La Rey announces retiremeňt as "universal ball" producer

(West Hollywood, CA) -- Empress LaRey, who for many years produced the annual "Universal Ball" female impersonator beauty pageant, has announced that she will be stepping down as producer after this year's event.

In an interview with "Cross-Talk", LaRey cited increased business responsibilities in other areas as the major reason for her decision. She says she will also step down as producer for the spring "Goddess" and "Miss Gay L.A." pageants after next year's events, although she will remain connected with the events as emcee for the foreseeable future.

The 1991 edition of the "Universal Ball", which was created by LaRey in 1969, will be held November 8 in its long-time home, the Mayflower Ballroom in the LAX area. [Kymberleigh Richards]

TS attorney funds writing competition on sexual identity

(Houston, TX) - In order to encourage legal research as it relates to the issues of sexual identity, including the gender mitmran annual writing competition has been announced at the University of Houston Law Center.

The student writing the best paper on topics relating to any area of the law dealing with sexual identity will receive a \$500 award from an endowment funded by transgendered attorney Phyllis Randolph Frye. Preference will be given in the final judging to papers dealing with transgender issues.

The law to be analyzed in the

competition papers will include employment (hiring discrimination, on the job transition, wrongful discharge); family (change of name, pre-operative change of gender, amendment of birth certificate, passports, validity of marriage before and after surgery, child custody and visitation); housing (refusal to rent, wrongful eviction); insurance (naming beneficiaries, electrolysis, hormones, psychological analysis, surgery and hospitalization, refusal to insure life); military (security risk, forced discharge, benefits); criminal (mistreatment during arrest, segregation while in jail or prison, withholding of hormones); probate (validity of being named heir after transition begins, validity of bequest to legal spouse before surgery if death is after surgery) and health (ethics of greed in overtreatment, ethics of bias in undertreatment, malpractice, defining sex, gender, role and appearance).

Frye hopes to set a precedent with the competition for law school in other cities. "Until (these) issues are thoroughly explored in the legal arenas, the progress of the gender community will be at a snail's pace)," she said. ["The New Voice"]

International Amnesty expands mandate on human rights

(London, England, U.K.) - The Nobel Prize winning human rights organization Amnesty International has expanded its mandate to include human rights for lesbians and gays, including language that will also protect transgendered people who are perceived to be homosexual.

At its September meeting in Japan, the or conscience" people who have been arrested for lesbian and gay rights advocacy, those arrested simply because they are homosexual following raids on bars or other gathering places even though they have committed no other crime, and people perceived to be homosexual because of the way they dress.

Observers note that while the expanded mandate does not specifically include transgendered people, transsexuals and transvestites will enjoy "spill over" protection. They cite incidents in such places as Singapore, where police sweeps against homosexuals have also caught up transsexuals and transvestites. While including transgendered people in the mandate would have been preferable, they note, it would have been all but impossible to win consensus approval from all of the 44 national Amnesty sections which decide policy for the international organization.

Protection for jailed sexual minorities was first proposed in 1974, and has been regularly put forward by various European and North American sections since then, but strong opposition from Asian, African and South American sections had always resulted in the proposal's defeat. The compromise proposal approved in September contained "escape clause" language recognizing that some of the national sections have cultural backgrounds resulting in different views of homosexuality around the world, permitting nations to adhere to their own cultural backgrounds. However, Derrick Mcguinness, spokesman at Amnesty headquarters, said "Clearly we now recognize sexual orientation as a fundamental human right to which (we) must respond."

Amnesty is an international human rights watchdog group which encourages governments around the world to respect certain fundamental human rights and to free "prisoners of conscience" arrested for exercising those rights. The 44 national sections represent more than 8,000 local Amnesty chapters working in over 70 nations. ["Renaissance News"]

FDA questions safety data on breast implants

(Washington, DC) -- Although more than two million women in the United States have silicone breast implants, manufacturers have not produced data that prove their safety, Food and Drug Administration officials say.

The agency has told the four American manufacturers of the implants, in letters sent over the weekend of September 13, that unless further data is submitted regarding the implants' safety, the products might have to come off the market.

Officials reviewing data received in response to an F.D.A. request earlier this year involved two few women and too few side effects, and had been collected in too short a time. The agency gave the companies a January 6 deadline to either submit new results or convince the agency that the data submitted were sufficient.

The implants, virtually all of which contain silicone, were among the many medical devices permitted to remain on the market without proof of safety and effectiveness when new regulation on medical devices began in 1976. Manufacturers were not required to submit safety data on the implants until this year. Doctors who study the use of implants have suggested that they can cause allergic reactions, painful muscle contractions, connective-tissue diseases or infections. While manufacturers concede that there may be side effects, they insist that an overwhelming majority of women who have them are happy with them. 150,000 women receive the implants annually in the United States, about 20 percent following breast surgery, and the remaining 80 percent because they are dissatisfied with the shape of their breasts.

Robert Rylee, chairman of the health care businesses section of Dow Corning, the nation's largest manufacturer of breast implants, thought the F.D.A.'s letter was unwarranted. However, Michael R. Mitchell, marketing manager for McGahn Medical Company, another implant manufacturer, said the company was not surprised and indicated a willingness to work with the agency to correct deficiencies in its safety data. Two other manufacturers, Bioplasty Inc. and the Mentor Corporation, did not make public comments. A fifth, Surgitek, was not among the companies permitted to make an initial application earlier this year, due to criticism over its polyurethane coated implant, which is suspected of causing cancer. Authorities unable to prove true gender of con artist

(Denver, CO) -- Police who arrested a person they say is a con artist who preys on elderly and gullible people have thus far been unable to substantiate their suspect's claim of having had a sex change operation.

Baroness Maria Thyssen VonHexun, also known as John James Gonzales, was arrested on charges of bilking at least two people out of \$2,300. VonHexun/Gonzales claims to have married a German nobleman, but authorities continue to have difficulty in determining her/his gender.

Police have had no trouble reconstructing VonHexun/Gonzales' past legal difficulties, however. She was ruled incompetent to stand trial on charges relating to that swindle.

On the first page of the standard contestant's contract for the Miss American Teen competition, along with the usual statements about residence and age, the contestant is asked to swear to the statement "I have always been a female". You won't find "tits in a can" at your local supermarket, but you will find bra inserts packaged that way at selected fashion boutiques, thanks to Damin Industries, Inc. of Los Angeles. The "Stay-Put Backless, Strapless Push-Up Bra" features 100 percent hypoallergenic polyurethane inserts that are, according to fashion designer Alaïa, "virtually undetectable" underneath his body-hugging, stretch knit dresses. The inserts come with adhesive wings and include detailed pictorial instructions mapping out effective bra angles for low-cut necklines. ["Vogue"]

Protesters who drowned out Governor Pete Wilson's speech at Stanford University October 2 have vowed to keep fighting what they say are the religious forces behind the governor's veto of a gay rights bill.
