

So... You're Thinking About Electrolysis

There are many things to consider before you embark on your journey into the wonderful world of permanent hair removal.

I thought I would contribute a few comments about electrolysis. In my wanderings in the last 6 months, I have learned a lot about electrolysis. Not to mention undergoing a good deal of it and I have found that there are many myths and many poor electrolysis clinics. So here are a few comments to possibly help people avoid some problems.

There are two kinds of processes practiced under the name electrolysis, thermolysis and true electrolysis. Both involve inserting a needle into the hair follicle and then applying a current.

In thermolysis, the current heats the hair follicle and attempts to kill the follicle by burning it. In electrolysis, the current creates a chemical reaction to produce sodium hydroxide which then kills the follicle.

The vast majority of electrolysists use only the thermolysis method because the machines are cheaper and the technique is easier to learn. However, it is not a very successful method, often resulting in about 75% hair regrowth.

The best techniques use what is known as "the blend". This technique came out of California and has been largely limited to the western United States, though it is now finally being adopted nationwide. The blend involves using two different currents to produce both thermolysis and electrolysis and reduces hair regrowth to about 15%. This technique is preferable not only because it minimizes regrowth, but it also minimizes skin damage.

Having to perform thermolysis 3 or 4 times on the same follicle can cause

severe skin damage, even if spaced over a year or so. Correctly done, there should be no permanent skin damage in electrolysis. You should not be able to tell you ever had work done on you a week or so after the procedure.

Thermolysis can be easily distinguished from electrolysis by whether you hold an electrode in one hand during the procedure. Since thermolysis involves burning the follicle by heating of the needle, it is unnecessary to induce a current in your body. However, electrolysis does require current to pass through the follicle, so you have to hold an electrode in one hand to produce a conduction path.

Finding a good electrolysist is a hit and miss proposition. The best way is word of mouth. A very few states have certification for electrolysists, but most states do not. In most states, anyone with an electrolysis machine can open a salon and go to work. If there is any regulation, it is generally by a cosmetology board who seldom has the expertise to judge the worth of a particular electrolysist. There is a national electrolysis association, but anyone with \$75 can join, so it is not a reliable indicator of someone's expertise.

Short of a recommendation, I would suggest the best way to find a good electrolysist is to call several and talk. Ask them to explain their procedures and see if they give you the feeling they have a good deal of experience, are not trying to snow you, and generally whether they seem knowledgeable and trustworthy. Be sure to ask them about their hygiene practices as well. Make certain they sterilize their needles before use and that they wear rubber gloves.

The chances of disease transmission in electrolysis are not great, but it is a form of microsurgery and the needle does make contact with your blood now and then, so you need to make sure that the salon is performing good sterilization and hygiene.

One thought for getting a recommendation is to call some dermatologists and ask them who they send their people to. You might call a university medical school dermatology department for such a recommendation as well.

Also, see whether the salon knows about and uses the blend technique or not. The fact that they use the blend does not make them a good electrolysist, but I wouldn't even consider going to one that didn't use it.

I would also avoid the less expensive places, you get what you pay for. I pay \$63 per hour, which is on the high end. When you do go, start with a short session, say, 15 or 30 minutes, and then wait a week before returning.

The area that was worked on should no longer be swollen and you should see no marks whatsoever. If you see black heads, small white scars, pits, a persisting rash, or if the area is swollen, then stop going immediately!

These are signs of poor technique and they can cause permanent skin damage! Some swelling or white heads are not uncommon a day or so afterward. I find my face stays swollen for several days after four one hour sessions, and even up to a week later there will be a very minor amount of swelling, but not much. It's not enough to see, but you can feel it because your face will seem a bit stiff.

If you have electrolysis on your beard, you will find what they call tombstones. These look at first sight like a blackhead, but in fact are dead hairs under the skin.

In order to be able to tweeze out the

hair during electrolysis, the hair must be long enough to grasp with tweezers. So you must let your hair grow out a bit before an electrolysis session. This means on your face that you should not shave for a few days before a session.

Often a follicle will have more than one hair growing out of it. One hair gets tweezed out by the electrolysist, but the others are beneath the skin. They will be pushed out in a few days. You can usually tweeze or squeeze them out when they appear. They are nothing to get worried about.

I have heard of TS's who started electrolysis with nice skin and ended it with skin that looked like a sponge. Correctly done, there will be no permanent skin damage, so don't compromise!

Another way to tell whether you are getting good care is that when done correctly, the hair should come out of the follicle without pulling on it. So if you find the electrolysist is frequently having to pluck hair, then they are doing it wrong. Not only can this cause skin problems, but it means the follicle is not being killed and the hair will come back in a month or so.

Different size hairs require different size needles as well as different currents and current blends. Your electrolysist should be able to explain to you what needle sizes they use where and what current blends they use for different parts of your body. If they can't or won't explain, then find a new electrolysist.

To remove a mustache takes about 16 to 18 hours on the average male, spaced over a minimum of about 6 months. After the first 10 or so hours the upper lip should be getting pretty smooth. Their will still be some whiskers, but the thinning should be dramatic!

There will still be hair that will grow and will require more work later on. At any given time, some amount of your hair is dormant and it takes about 6 months for this dormant hair to become active again. So you will have to go to electrolysis for at least that time (and more likely longer) to achieve complete removal of the hair on any part of your face in particular.

To remove a complete male beard takes on average about 200 hours and will take probably 1 to 2 years, depending on how much electrolysis you have at a sitting. Don't ever do more than an hour or so on any one part of your skin. You can do say, one hour on one side of your upper lip, and another hour on the other side. Much more than one hour on the same area of the skin significantly raises the possibility of permanent skin damage.

I do about 4 hours a week, a hour at a time on different parts of my face, for example. After an hour session, you should see definite thinning on the region.

Electrolysis is painful, though I found it was not nearly as bad as I had imagined. The most painful area is probably the upper lip, right under the nose.

In general you will find that electrolysis is a bit more painful along the frontal axis of symmetry of your body (i.e., right down the front of your body). The nerves in your skin are broken into nerves for the right side of your body and nerves for the left side. Along the center of your body, the two sides overlap, so you have twice as many nerve endings along the center axis of your body. Skin in this area may be more sensitive to pain during hair removal.

The pain is not that bad and will vary from individual to individual. I even find it varies with me, depending on whether I am in good spirits or depressed.

After having electrolysis, you have to be careful with your skin for at least a couple days. Avoid lots of sun and try to avoid sweating heavily for a day or two. Don't put makeup over an area that has been worked on for a day or so, and don't even think of shaving over it for at least a day. Even then I would recommend being careful and using an electric razor to minimize the skin irritation.

You should swab the area worked on with Sea Breeze or some other type of antiseptic astringent. This will keep the now vacant hair pores clean and free from infection. After a couple days, the pores will close up and this will no longer be necessary.

You should also apply some sort of moisturizing lotion over the worked on area for a few days. I highly recommend using an Aloe Vera gel since it will help the burn heal. Be sure to avoid anything with perfumes or other things than can cause irritation.

I would avoid home electrolysis kits or the kinds of "permanent" hair removal devices you see in magazines. You can do home electrolysis, but you are more likely to damage your skin than anything. Get a professional to do it or don't do it all. Having hair is better than having scars or pits on your face. As for all these other devices that promise permanent hair removal, they are a rip off. You are not going to be able to permanently remove hair with a \$25 device. I am sorry to say that there is no medically known way to permanently and safely remove hair other than to have real electrolysis performed. These devices may kill a hair for a month or so, but it will return. Save your money and save your skin the wear and tear.

Well, that is my core dump on what I have learned about electrolysis. The bottom line is be informed and don't be afraid to change electrolysists if you are dissatisfied. Correctly done, it is a safe and effective way to permanently remove hair. But it does have to be done correctly and there are a lot of poor electrolysists out there. So just be careful, look for experience, and be an informed consumer. It isn't any different than choosing a doctor or an auto mechanic.

I hope this stuff is useful.

Regative Situation

I Didn't have to glance twice at the snapshot from last month's vacation to the North Carolina Outer Banks to realize that the moon rising over the largely deserted Nags Head Beach at dusk was not celestial, but anatomical. Apparently on a dare, my 16-year-old son decided to taunt his older brother (holding the camera at the time) by showing him what comedian Dan Aykroyd once made Famous on Saturday Night Live as the "workman's smile."

Adolescent irreverence notwithstanding, my son might not have committed posterior to posterity had he thought about the 26-year-old Tampa, Fla., secretary who, some years back, permitted her boyfriend to photograph her in "various states of undress" only to have copies of those photos (which she later regretted and destroyed along with the negatives) show up at a party in a photo album alleged to belong to an ex-employee of the photo processor who developed her film.

Wendy Ellingson, the subject of those photos, now has sued that former employee, two of his co-workers, and the Jack Eckerd Corp, parent company of Eckerd Express Photo, the outfit that developed her pictures.

The photo album that was believed to have been the hit of numerous parties is said to contain pictures of more than 100 women, some of them totally naked.

It is an almost universal standard throughout the photo-processing business that the copying of a customers photos by an employee is the grounds for immediate dismissal. Bill Pfeiffer, business manager of Cord Camera & Video, which operates 17 photo-processing outlets in central Ohio, acknowledged that rule but said his company has rarely had to use it.

Over the past four years, he allowed, "It seems there was an incident where a person was found with some prints on them and had to be let go."

"As for risque," he said, "we get a lot of them that come through the lab. If it is just slightly off-color, or there is a

degree of nudity, you can censor it. We don't have near the trouble of people trying to slip pornographic things by on us that we did years ago."

What photo processors do see, however, to hear a few of them talk about it, may not be criminal, though it suggests a fundamental lack of understanding by consumers that other human beings -- strangers -- will be staring at what the camera shutter only winked at.

"You wouldn't believe it if you saw it," maintained Kris Gross, for six years a photo processor in both Cleveland and Columbus. "We're talking nudity. When I worked at the Cord at Reynoldsburg, there was a dentist who regularly brought in photos of his wife naked. She'd be setting the table, talking on the phone, taking out the garbage, and that was taken outside.

"We had one guy who was trying to do gay pornographic greeting card covers. It was a crotch shot over a birthday cake... We had a man and a woman who made love in his office, or maybe it was her office." She recalls one particular roll of film that really stopped her in her tracks. On the negative it resembled some form of mayhem or mutilation. She remembered, "I'm printing this roll of film, and I'm looking at this negative going, 'What the hell is that?' It sort of looked like it might be murder or something. When it came out (in print) it was a pig."

A group of revelers at a pig roast apparently decided that before they put the splayed and gutted porker on the spit, it might be kind of neat to photograph

it sitting on the toilet.
"They were putting hats
on it," Gross, incredulous,
she remembered.

"We've had nude shots of different types," said Jodi Wolfe, manager of Sunbury 1-Hour Photo. A male acquaintance of Wolfe's from high school

recently brought a roll of film into the shop and asked specifically that Jodi process it.

What was it?

"Him naked," she wearily said.

The strangest thing she has seen lately, though, was a roll of film brought in by a football coach. The first half of the roll depicted the coach going about his duties. Nothing unusual. But of the remainder she said, "the other half of the roll had him dressed up as a girl, pantyhose and all."

A few depicted him in full drag; others, she added, showed him in nothing but a bra, panties and pantyhose.


It sort of makes a photo of a half-moon on the beach at Nags Head seem as pale as it was when the camera clicked. ["A Negative Situation" - originally appeared in The Columbus Dispatch on September 4, 1991. I thought it was pertinent to our club for several reasons.

First of all, it reminds us that we must be discreet about getting photographs developed, Lord knows we take just a few! Unless you are ready to go public about your "hobby", you might want to be sure not to use half of a roll wherein the opposite half reveals your other identity.

Another precaution would be to take the film to a photo processor different from the one close to home where you take all your "regular pics" to be developed. You just can't be too careful, because when some people discover your little secret, they may think it's bizarre and can't keep quiet about it. Which brings me to my second point.

Sad to say, Although we've made some strides in the past few years, the general public does not seem ready to accept crossdressing (especially M 2 F). Not when a photo processor, who has probably seen it all, thinks a football coach in drag is stranger than a gutted pig on a toilet or a woman taking out the trash in the nude while her husband the dentist takes pictures of her.

This just emphasizes our need to educate the public about transgendered issues and let them know what we're all about. That is one of the main purposes of The Crystal Club and other such support groups. Hopefully, someday we won't have to be so clandestine about our activities. I.F.G.E. TV Dinners



some kind of income one can not meet even the most basic of needs.




